Motion 2014/06/16: 01 - ATKINSON/ERICKSON

WHEREAS Part 12.1.c.i of UVSS Issues Policy states, "Every student has the right to accommodations that allow for their equal participation in academic and non-academic aspects of their campus community; and

WHEREAS the UVSS supports the expanded transit loop but has serious concerns about the removal of accessible parking spaces and drop off location for students and community

members accessing the north end of the SUB; therefore

BIRT the UVSS advocate for a drop off loop with accessible parking between the UVSS and GSS buildings.

Motion 2014/06/16: 02 - ATKINSON/ERICKSON

WHEREAS in 2002 the BC Government passed a law which removed teachers' rights to collectively bargain many guarantees that had been previously negotiated; and WHEREAS the BC Government decreed that these items could never be negotiated in the future; and

WHEREAS one of these guarantees was the right to bargain class size and composition; and

WHEREAS the BC Supreme Court has struck down the BC Government's law twice, ruling that it is illegal and unconstitutional; and

WHEREAS in the February 2014 ruling of Supreme Court Justice Susan Griffith, she argued that the BC Government bargained in bad faith with teachers and said: "The legislation undoubtedly was seen by teachers as evidence that the government did not respect them to be valued contributors to the education system, having excluded them from any freedom to associate to influence their working conditions. This was a seriously deleterious effect of the legislation, one adversely disproportionate to any salutary effects revealed by the evidence."; and

WHEREAS in the ruling of Supreme Court Justice Susan Griffith, she argued that the BC Government provoked a strike because "the government thought that a teachers strike would give the government a political advantage in imposing legislation that the public might otherwise not support."; therefore

BIRT the UVSS issue a public statement supporting teachers' constitutional right to collectively bargain their working conditions, including class size and composition, as guaranteed under the Canadian Charter of Rights and Freedoms; and

BIFRT the UVSS Chairperson and the Director of External Relations collaborate on a news release that incorporates this statement of support into the current draft news release, based on the amended Motion 2014/06/02:03 passed at the previous board meeting; and

BIFRT the positions stated in this motion and Motion 2014/06/02: 03 are communicated in tandem in the news release.
