MOTION 2025/10/28: 01 - KING

WHEREAS one of the values of the UVSS is Decolonization

WHEREAS student surveys show that decolonization and social justice are among their top values of the UVSS

WHEREAS it is important that policy is aligned with the goals of the UVSS and student needs

BIRT that the UVSS adds the section titled Decolonization in Issues policy

BIRT that the UVSS amends the Issues policy as is in package [Issues Policy 1 - Decolonization Policy](#)

MOTION 2025/10/28: 02 - FOSTER

WHEREAS the anti-racism section of UVSS Issues Policy has outdated language

WHEREAS It is important as a Student Union that guiding policy represents students and their interests

WHEREAS Students of Colour are a marginalized community on campus and it is essential that the UVSS has language and policy that allows the UVSS to advocate for Students of Colour effectively

BIRT the UVSS amends the Issues policy as is in the package [Issues Policy 2 - Anti Racism Policy](#)

WHEREAS there is a need to clarify the focus and membership of our efforts as a student society and the services we aim to provide

BIRT the UVSS amends the UVSS bylaws as in the package [Bylaw 1 - For Credit Course Coverage Changes](#)

MOTION 2025/10/28: 04 - FOSTER

WHEREAS the Society is sustained by the leadership of students who nominate themselves for seats on the Board of Directors

WHEREAS the roles of Faculty Representatives often go unfilled, complicate the nomination process, and often delay elections significantly

BIRT the UVSS amends the UVSS [Bylaw 2: Faculty Representative Changes](#)

WHEREAS the students of UVic look to the Student Society for representation, advocacy, and leadership

WHEREAS the UVSS Board of Directors does not currently apply the clear, straightforward, and commonly used among other universities titles of President and Vice-President(s) to its lead directors

WHEREAS it is in the interest of the Society and the student body that the UVSS present a transparent and easily understood model of leadership, both with the goals of public relations and internal coordination,
