WHEREAS student surveys show that decolonization and social justice are among their top values of the UVSS

WHEREAS it is important that policy is aligned with the goals of the UVSS and student needs

BIRT that the UVSS adds the section titled Decolonization in Issues policy **BIRT** that the UVSS amends the Issues policy as is in package <u>Issues Policy 1 - Decolonization Policy</u>
